

# 2026 Workers' Comp Rates Across Canada ☐



All provinces and territories have announced their 2026 workers' comp premiums:

- Ontario, Saskatchewan and Yukon are cutting average premiums;
- BC, Manitoba, New Brunswick, Newfoundland, Nova Scotia, Northwest Territories and Nunavut are keeping premium rates the same; and
- Alberta, Prince Edward Island and Québec are increasing premiums.
