BRITISH COLUMBIA

Apr 5: Newly tabled <u>Private Member Bill M 220</u> requires owners of designated public premises to install, maintain, test and post signs about the presence and location of automated external defibrillators (AEDs) on the property.

Action Point: Implement an AEDs program to save lives at your

workplace.

Jun 8: WorkSafeBC updated the OHS Regulation to bring first aid training and kit requirements into line with revised CSA standards, namely, CSA Z1210-17 and CSA Z1220-17, and to clarify first aid rules for high-risk remote workplaces. Key changes include requiring first aid assessments to consider situations where first aid attendants can't get to injured workers.

Action Point: Implement a <u>First Aid Compliance Game Plan</u> at your workplace.

May 30: That's the deadline to comment on proposed changes to the OHS First Aid Regulation. Highlights: i. First aid training would have to meet CSA Z1210-17; ii. Workplace first aid kits would have to meet CSA Z1220-17; and iii. Revised definition of high hazard work.

Action Point: Implement a <u>First Aid Compliance Game Plan</u> at your workplace.

May 30: Comments ended on <u>proposed changes</u> to the *First Aid Regulation* designed to harmonize record keeping and minimum training requirements (and definition of "high hazard work") in New Brunswick with the OHS rules of other jurisdictions.

NOVA SCOTIA

Jan 17: With OHS division inspectors focusing on home healthcare agencies, the agency issued <u>new guidance</u> to help employers comply with current regulatory rules for protecting workers working in isolated locations where an isolated workplace first aid plan is required.

PRINCE EDWARD ISLAND

Oct 6: The WCB reminded PEI employers of their responsibility under OHS laws to provide adequate first aid supplies and services at the workplace, as well as first aid training to workers. For their part, workers are responsible for safe conduct, reporting illnesses and injuries and using first aid resources when needed.
