August 5–Federal–Deadline to comment on [proposed](#) child privacy law.

August 9–Alberta–New tow truck [traffic safety regulations](#) take effect.

August 18–Northwest Territories/Nunavut–New WSCC Connect electronic filing rules for [Employer's Report of Incident, Injury, and Fatality](#) forms take effect.

August 21–New Brunswick–Deadline [to comment](#) on [proposed updates](#) to WorkSafeNB occupational hearing loss coverage rules.

August 22–Federal–Deadline [to comment](#) on *Free Trade & Labour Mobility in Canada Act* regulations.

August 28–Yukon–Deadline to complete [online survey](#) on nonconsensual publication of intimate images.

August 29–BC–New [OHS Guidelines](#) for mixing, preparing and priming hazardous drugs take effect.

Sept. 1–Nova Scotia–Deadline to implement [workplace harassment prevention policy](#).

Sept. 1–Nunavut–Deadline for employers [to apply](#) for Summer Employment for Nunavut Students program.

Sept. 5–BC–Deadline [to comment](#) on proposed “certified safe for use” OHS regulations for equipment.

Sept. 5–BC–Deadline [to comment](#) on [proposed amendments](#) to OHS automotive lifts regulations.

Sept. 5–Yukon–Deadline to complete WSCB [online survey](#) on administrative monetary penalties for WSC violations.

Sept. 8–NW Territories/Nunavut–Deadline for compliance vendors [to apply](#) for WSCC OHS Funding Program assistance.

Sept. 14–Federal–Deadline [to comment](#) on proposed emergency registration of pesticides PMRA regulations.

Sept. 24–Ontario–Deadline [to apply](#) for [Rural Ontario Development \(ROD\) program](#) funding.

Sept. 26–BC–Deadline [to comment](#) on [proposed changes](#) to OHS combustible dusts regulations.

Sept. 26–Ontario–Deadline [to comment](#) on proposed geologic carbon storage regulations.

Sept. 29–Alberta–Deadline to comment on proposed changes to [WCB housekeeping allowances policy](#).

October

Oct. 1–BC–New [OHS regulations](#) for toilets at construction sites take effect.

Oct. 1–Ontario–Deadline [to apply](#) for SDF Training stream funding.

Oct. 1–Québec–New [OHS regulations](#) for personal lifting devices and mobile personnel platforms at construction projects take effect.

Oct. 1–Québec–New OHS regulations for workplace [safety committees](#), [safety representatives](#) and [safety liaison officers](#) take effect.

November

December

Dec. 1–Québec–New Class 1 heavy vehicle drivers licence [regulations](#) take effect.

Dec 31–Yukon–[Air Emissions Regulation](#) permit requirements for new large-scale biomass burning units take effect.

Note:

*In BC, workers' comp filing deadlines are staggered among Feb. 28, March 15 and March 31 based on the final 2 digits of the employer's account number.
